Claim Procedures - Motor Insurance (Theft or attempted theft of vehicle)

- 1. Report the crime to police authorities immediately
- 2. Note down the essential information e.g. name of the car park operator, car park space number.
- 3. Complete and sign the attached Motor Theft Claim Form and Consent Letter. Then return it together with a copy of the following documents to us:
 - Vehicle Registration Document (both sides);
 - Report chit from police authorities;
 - Police statement and other relevant documents from other authorities;
 - Purchasing contract of Insured vehicle;
 - Recent maintenance record of Insured vehicle; and
 - Hire Purchase Agreement of Insured vehicle (if any).
